Cllr Highwood stated that this application had previously been approved but the this has now run out. The Parish Council would like to comment that the Flood Report is incorrect and that it is in fact in Flood Zone 2 and not 1 as is stated in the application.

It was proposed by Cllr Highwood and seconded by Cllr D Papas and RESOLVED by all members present to object to this application on the following grounds.

The Parish council wish to object on the following grounds: -

Flooding

Over the years, many applications have been submitted for this site (several having been refused) and flooding has always been a major issue as the majority of the site lies in Flood Zone 2.

The site has flooded as recently as 2013 and, as the FRA admits, "borders a dry island" which illustrates the vulnerability of this location - indeed the FRA states that "post development, the site will become highly vulnerable". Ingress and egress of the site is also a major issue as, in the floods of 2001, that "dry island" was inaccessible by road.

We also note that the FRA states that the site is primarily in Zone 1 whereas we believe this is misleading as we

believe it is primarily in Zone 2.

The Parish Council are also concerned about the safety of the Junction and the Visibility Sway.
